I hereby authorize and request the Assistant Commissioner of Patents of the United States of America to issue Letters Patent upon the aforesaid application, division, extension, continuation or reissue, to the AeroScout, for the sole use and benefit of said AeroScout, its



I covenant with said AeroScout, its successors, assigns and legal representatives, the interest and property hereby conveyed is free all prior assignment, grant, mortgage, license or other encumbrance.
