WHEREAS, I,

(1) Gareth OSBORNE of Winchester, Hampshire, Great Britain

have invented certain improvements in

**AN APPARATUS FOR KEY ACTUATION AND ASSOCIATED METHODS**

I ALSO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom to the said ASSIGNEE of my entire right, title and interest.

I FURTHER HEREBY sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including, without limitation, the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries. I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.


I HEREBY covenant that I have not and I will not execute any agreement in conflict herewith.
