## ASSIGNMENT

WHEREAS, I, CHRISTOPHER DAVID GILLESPIE of 86 Church Street, Stouffville, Ontario, L4A 1E3, Canada have invented certain new and useful improvements in **FAN UNIT WITH BYPASS VENT HOLES**, which was filed on April 26, 2010 and assigned United States Serial No. 12/739,809; and

I do hereby covenant and agree, for myself, my heirs and my legal representatives, that I will assist said ASSIGNEE in the prosecution of the application herein identified; in the making and prosecution of any other applications for Letters Patent that said ASSIGNEE may elect to make covering the invention herein identified, as hereinbefore set forth; in vesting in said ASSIGNEE like exclusive title in and to all such other applications and Letters Patent; and in the prosecution of any interference which may arise involving said invention, or any application or Letters Patent herein contemplated; and that I will execute and deliver to said ASSIGNEE any and all additional papers that may be requested by said ASSIGNEE to fully carry out the terms of this assignment.

And I do hereby authorize and request the Commissioner of Patents to issue all Letters Patent of the United States that may be granted pursuant to the application aforesaid, or for said invention, to said ASSIGNEE, its successors and assigns, in accordance with this assignment.
