

And we hereby authorize and request any patent that issues to be issued to Trek, Inc. as the assignee of the whole right, title, and interest thereto.


And we further agree to sign and properly execute such necessary and lawful papers for applications for patents, for filing subdivisions of said applications for patents, and for obtaining
