Akamai Technologies, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 20th day of August, 1998, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the stock of Netli, Inc., a corporation incorporated on the 1st day of March, 2000 pursuant to the General Corporation Law of the State of Delaware.
