NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, ASSIGNOR hereby confirms ASSIGNEE's entire ownership of ASSIGNOR's share in the exclusive right, title and interest to patent rights on all the inventions claimed in the Patents, including (a) Letters Patents to be obtained therefore on said applications; (b) all improvements and modifications of the above-identified Patents and Patent applications; (c) all divisions, continuations, continuations-in-part, renewals, substitutes, re-examinations, reissues, and extensions of said applications, and (d) the right to claim for any of said applications the full benefits and priority rights under the Paris Convention and TRIPS/WTO agreements ; such rights, title, and interest to be held and enjoyed by ASSIGNEE, its successors and assigns, to the full end of the term or terms for which the Patents may be granted as fully and entirely as would have been held and enjoyed by ASSIGNOR had this Assignment not been made.

The ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment; ASSIGNOR hereby undertakes to execute and deliver to ASSIGNEE upon request all lawful documents which may be requested by ASSIGNEE, and to furnish ASSIGNEE with all facts relating to said Patents as may be requested.

The Patents may then be published and delivered in the name of ASSIGNEE in place of ASSIGNOR in accordance herewith; record of this assignment with the Patent Offices will be made by the ASSIGNEE who will bear the corresponding cost.

ASSIGNEE shall have the right to maintain these Patents/patent applications in force and to exploit them directly or indirectly as the sole owner thereof.

ASSIGNEE will be entitled to undertake, resume or continue, in its own name but at its own expense, risks and profits, as plaintiff or defendant, all rights, proceedings or actions concerning the assigned Patents including the right to legally pursue any former or future usurpation.

ASSIGNEE may also claim or obtain for its exclusive benefit, all damages owed by infringers of the Patents for infringing acts committed before or after the present assignment.


Record of this assignment with the USPTO will be made by the ASSIGNEE who will bear the corresponding cost.


