ASSIGNMENT OF U.S. PATENT APPLICATION

5. Inventor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in the Assignee.

6. Inventor hereby yet further agrees to, with respect to the referenced patent application, at the expense of the Assignee:


- i) testify in any legal proceedings,


