ASSIGNMENT

WHEREAS, we, Bjørn Torstein Bruun, of Trondheim, Norway; Erik Nyrnes, of Trondheim, Norway; and Jo Eidsvik of Trondheim Norway, have invented certain new and useful improvements in FORMING A GEOLOGICAL MODEL, for which an application for Letters Patent of the United States has been made, and which may be identified in the United States Patent Office by Application No. 12/743,338, filed May 17, 2010.
