

ORDER OF INFORMAL PROBATE OF WILL AND APPOINTMENT OF PERSONAL REPRESENTATIVE

- 5. The original, duly executed, and apparently unrevoked last will and testament of Henry Happy dated October 15, 2008 (the "decedent's will") is in the Court's possession and appears in all respects to be the valid last will of the decedent.
- 6. Any notice required by Section 72-3-106, Montana Code Annotated, has been given, and the application is not within Section 72-3-213(5), Montana Code Annotated.
  - 7. The time limit for original probate has not expired.
