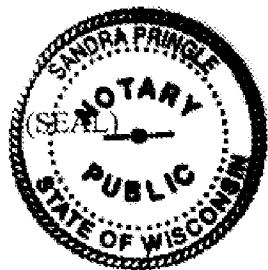
statutes, or regulations; said foreign applications to be filed and issued in the name of **Cooper Technologies Company** or its designee insofar as permitted by applicable law;
