- iii) execute all divisional, continuation, continuation-in-part, reissue and substitute applications,

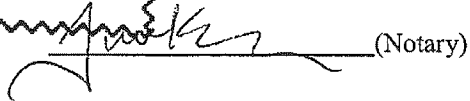

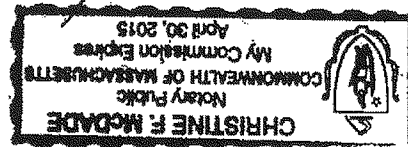
