

And I further agree to execute all necessary and lawful future documents, including assignments in favor of Assignee, or its designees as Assignee or its Assignees may from time-to-time present to us in order to perfect title in said Invention, modifications, and improvements in said Invention, applications and patents of the United States and countries foreign thereto;

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing divisions, continuations and continuations-in-part of said application for patent, and/or, for obtaining any reissue or reissues of any patents that may be granted for our aforesaid Invention, as the Assignee thereof shall hereafter require and prepare at its own expense.
