ASSIGNMENT

I. WHEREAS, I, Hamish G. MacDougall, residing in Sidney, Province of New South Wales, Commonwealth of Australia, have invented, jointly with other co-inventors, certain new and useful improvements to the camera box, the goggle insert, the occluder, and the circuit board layout and the lens focus mechanism, but excluding any items developed by me prior to January 13, 2003 or after October 12, 2003 or that were in the public domain and/or constituted prior art as of January, 2003 (herein, collectively "the MacDougall Inventions") of the video oculography system in the PORTABLE VIDEO OCULOGRAPHY SYSTEM, described and claimed in United States Patent Application filed November 7, 2003 and bearing the United States Patent and Trademark number 10/704,529 (herein "said application");

II. AND, WHEREAS Neuro Kinetics, a corporation of Pennsylvania, having a place of business at 128 Gamma Drive, Pittsburgh, PA. 15238, hereinafter called the "assignee", is desirous of acquiring my entire right, title, and interest in and to the MacDougall Inventions of said application.

III. NOW, THEREFORE, good and valuable consideration the receipt of a portion of which consideration is hereby acknowledged, I do hereby assign, sell, transfer, and set over unto said assignee the entire right, title and interest in and to the MacDougall Inventions which are set forth in said application for the United States and all foreign countries and all regular applications claiming the benefit of said application, and any divisionals, reissues, continuations and/or renewals thereof to the extent that such claims specifically include a MacDougall Invention.

IV. I covenant that I am the lawful owner of the MacDougall Inventions and that the same are unencumbered, that no license has been granted to make, use, or sell the MacDougall Inventions and that I have the full right to make this assignment.

V. I, the undersigned hereby assign my entire right, title and interest in the MacDougall Inventions as set forth in sections I-IV above.

This assignment shall be binding upon my heirs, executors, administrators, and/or assigns, and shall inure to the benefit of the heirs, executors, administrators, successors, and/or assigns, as the case may be, of said assignee.
