RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this “Release”) is made as of September 7, 2010 (“Effective Date”) by and between Roundtable Healthcare Capital Partners, L.P., a Delaware limited partnership (“RHP”) and Roundtable Healthcare Capital Investors, L.P., a Delaware limited partnership (“RHI,” and together with RHP, collectively, the “Secured Party”) and Bioniche Teoranta, a company incorporated under the laws of Ireland with number 130418 (the “Grantor”), with its principal office at Inverin, Co. Galway. Capitalized terms used in this Release, but not defined in this Release, have the meanings ascribed to such terms in the Facilities Agreement (defined below).

WHEREAS, Secured Party and Grantor are parties to that certain Facilities Agreement, dated December 16, 2008 (including all annexes, exhibits and schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “Facilities Agreement”);

WHEREAS, pursuant to the Facilities Agreement, Secured Party and Grantor entered into that certain Intellectual Property Security Agreement dated December 16, 2008 (the “Intellectual Property Security Agreement”), pursuant to which Grantor granted, assigned, conveyed, mortgaged, pledged, hypothecated and transferred to Secured Party a Security upon all of its right, title and interest in, to and under the Ultiva Intellectual Property (as defined in the Intellectual Property Security Agreement), including, without limitation, the patents set forth on Schedule A attached hereto;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on December 16, 2008 at Reel/Frame 021985/0302; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels, releases, reassigns, conveys and transfers any and all Security it has in the Ultiva Intellectual Property.

Upon Grantor’s request and expense, Secured Party shall take all further actions, and provide to Grantor, Grantor’s successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.




