PATENT COLLATERAL AGREEMENT

to secure performance of all Secured Obligations of Debtor as set out in that certain Security Agreement dated as of November 3, 2008 among Debtor, certain affiliates of the Debtor and the Agent, as the same may be amended, modified, supplemented or restated from time to time (the *"Security Agreement"*).

Debtor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the assignment, mortgage, pledge and security interest in the patents, patent applications and patent licenses made and granted hereby are more fully set forth in the Security Agreement.
