PARTIAL RELEASE OF PATENT SECURITY AGREEMENT

THIS PARTIAL RELEASE OF PATENT SECURITY AGREEMENT (this "Release") is made as of September 1, 2010 (the "Effective Date") by Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent") for the benefit of The Cutex Company and Medtech Products Inc. (the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement, dated as of March 24, 2010, between the Grantors and the Administrative Agent (the "Security Agreement"), among other things, the Grantors pledged, assigned and granted to the Administrative Agent a continuing security interest in all of their right, title and interest in and to the patent registrations and applications set forth on Schedule I hereto along with the goodwill associated therewith (collectively, the "Patents");

WHEREAS, the Patent Security Agreement relating to the Patents was recorded with the Patent Division of the U.S. Patent & Trademark Office on March 29, 2010, at Reel 024128 and Frame 0786;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Patents.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Patents, it hereby assigns and transfers such rights, title or interest to the relevant Grantor.



Other than the foregoing release of the Patents, the Administrative Agent hereby confirms its lien on and security interest in all right title and interest in and to all other Intellectual Property and other Collateral pledged to it under the Security Agreement.
