ASSIGNMENT

WHEREAS, we, PARK, Man Uk, a citizen of Republic of Korea residing at Woongjin Coway R&D Center, Seoul National Univ. Research Park, San 4-1, Nakseongdae-dong, Gwanak-gu, Seoul 151-851, Republic of Korea; and PARK, Seong Won, a citizen of Republic of Korea residing Woongjin Coway R&D Center, Seoul National Univ. Research Park, San 4-1, Nakseongdae-dong, Gwanak-gu, Seoul 151-851, Republic of Korea (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled HEATING APPARATUS, for which an application for Letters Patent of the United States is being concurrently filed in the United States Patent and Trademark Office;



Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of applications and the perfecting of such right, title, and interest thereto in said ASSIGNEE.
