
ASSIGNMENT AND AGREEMENT

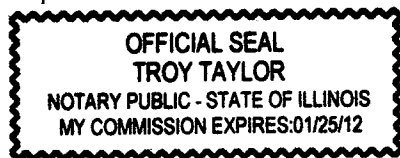

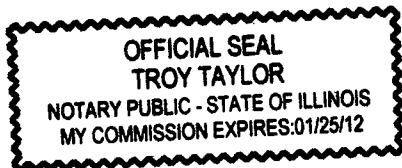

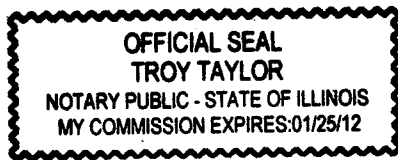
