ASSIGNMENT

- c. to perform all affirmative acts which may be necessary to obtain a grant of a valid United States patent to the Assignee on any continuation, division, reissue or reexamination of any of the Assigned Patents.

The Assignor hereby covenants that it has the full right to convey the right, title and interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict therewith.
