## ASSIGNMENT

WHEREAS, I, RICHARD A. PROULX, residing at Alta Loma, California, a citizen of the United States of America (hereinafter referred to as "ASSIGNOR"), have invented and own a certain invention entitled "TRIMMER HEAD FOR USE IN FLEXIBLE LINE ROTARY TRIMMERS HAVING IMPROVED LINE LOADING MECHANISM," for which application for Letters Patent of the United States of America has been executed on even date herewith; and

authorizes and requests the Commissioner for Patents to issue said Letters Patent or any legal equivalent thereof to said ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said legal equivalents thereof in the United States or in any foreign country which may be necessary or desirable to carry out the purposes thereof.
