
ASSIGNMENT

WHEREAS, I, GEOFFREY B. RHOADS, of West Linn, State of Oregon, have invented a certain invention, entitled METHOD AND APPARATUS FOR ASSOCIATING IDENTIFIERS WITH CONTENT, for which I have made application for Letters Patent of the United States, said application having been filed by me on October 7, 2008, and assigned application no. 12/247,021; and
