Assignor:

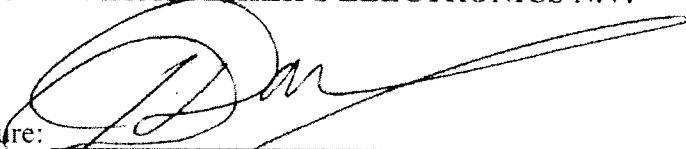

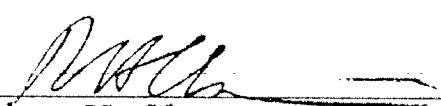
