RELEASE OF SECURITY INTEREST IN PATENTS

NOW THEREFORE, for the sum of \$10.00 and other good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby terminate the Security Agreement and relinquish and release the entirety of the security interests in the Patents and reassigns forever to Grantor all right, title and interest of any nature whatsoever which the Secured Party holds in or to each Patent and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor.
