SERVICE CEILING, IN PARTICULAR FOR LABORATORIES, AND METHOD OF INSTALLING SUCH A CEILING


described in international application PCT/EP2006/009143 and for which an application for Letters Patent of the United States of America was executed on the date of execution of this assignment;
