INTELLECTUAL PROPERTY ASSIGNMENT

WHEREAS, Juan Cortes, as an employee, owner and officer of INK WHEELS, INC. NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignor hereby confirms and acknowledges the sell, transfer, assign, quit claim and delivery to Assignee, effective as of the Effective Date, of all right, title and interest in and goodwill to the Specified Intellectual Property, as well as the right to seek or obtain any recovery, whether monetary, injunctive or otherwise, from any person or entity for past, present or future infringement or violation of any of the rights under the Specified Intellectual Property.

FURTHER, Assignor's assignment and transfer to Assignee further includes the entire right, title and interest in any and all inventions in and to the "Specified Intellectual Property" and any patents filed therefore, including all United States Letters Patents (such as reissuances, continuations, divisional, provisional, continuations-in-part, revisions, extensions and reexaminations thereof), which may be granted thereon, all priority rights under the International Convention for the Protection of Intellectual Property for every member country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed in any foreign countries to said inventions, and all patents granted in any country to said invention; and Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patents for said invention to Assignee in accordance with the terms of this Assignment;

STILL FURTHER, Assignor covenants that it has the full right and title to convey the interest assigned, and that it has not executed, and will not execute, any agreement in conflict herewith;

AND HEREBY further covenants and agrees that it (by and through Juan Cortes as the employee/designer of the Specified Intellectual Property) will communicate to Assignee any facts known to it/him regarding said designs, inventions and applications, and testify in any legal proceeding, sign all lawful papers, execute any and all patent and/or copyright
