
ASSIGNMENT

WHEREAS, we, GEOFFREY B. RHOADS, of West Linn, State of Oregon and NEIL E. LOFGREN, of White Salmon, State of Oregon, have invented a certain invention, entitled USING EMBEDDED IDENTIFIERS WITH IMAGES, for which we have made application for Letters Patent of the United States, said application having been filed by us on October 23, 2001, and assigned application no. 10/002,954; and


