WHEREAS I, **MARTIN POHANKA**, a German citizen, residing at Stuttgart, Germany, have invented certain new and ornamental improvements in a

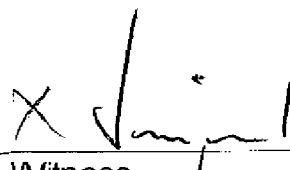

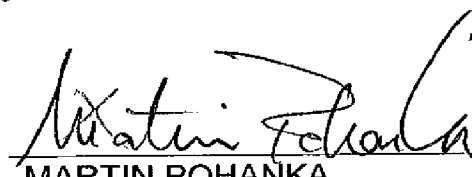
for which an application for Letters Design Patent of the United States of America was executed on the date of execution of this assignment;
