RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made as of September 22, 2010, by BNP Paribas ("Secured Party"), in favor of Roll Coater, Inc., a corporation organized and existing under the laws of Indiana ("Company").

W I T N E S S E T H:

WHEREAS, Company executed a Security Agreement on November 24, 2004 granting a security interest to Secured Party in Patent Collateral as set forth in the attached Schedule A;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on November 30, 2004 at Reel/Frame 016087/0927;

WHEREAS, Company executed a Security Agreement on May 14, 2008 granting a security interest to Secured Party in Patent Collateral as set forth in the attached Schedule B;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on May 15, 2008 at Reel/Frame 020986/0209;

WHEREAS, Company has satisfied its obligations under the Security Agreement; and

WHEREAS, Secured Party has agreed to release all its rights in the trademarks in Schedules A and B covered by the Security Agreements (collectively, the "Released Collateral"), and to re-convey any and all rights it may have in the Released Collateral to Company:

NOW, THEREFORE, for good and value consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

1. All security interests granted pursuant to Security Agreements are hereby released. Secured Party hereby reconveys to Company, without recourse or warranty, all Secured Party's right, title, claim and interest in and to the Released Collateral, all proceeds thereof, all rights corresponding thereto including but not limited to all rights to sue for past, present and future infringements and all rights to any reissue, division, continuation, renewal, extension and/or continuation-in-part thereof.

2. This Release may be executed in two counterparts, each of which shall be deemed to be an original and all such counterparts shall constitute but one and the same instrument.


