### NUNC PRO TUNC ASSIGNMENT


WHEREAS, Vivoxid Ltd., a company organized and existing under the laws of Finland and having its principal office at Biolinja 12, Turku, Finland, ("Assignor"), is the assignee of record of the intellectual property rights set forth in Schedule A ("Intellectual Property"), attached hereto;

WHEREAS, NovaMin Technology, a company organized and existing under the laws of the State of Delaware and having its principal office at 13859 Progress Blvd. #600 Alachua, Florida, United States, ("Assignee"), desires to acquire the entire right, title and interest in and to the Intellectual Property identified above, and all patents which may be or have been obtained for said Intellectual Property, as set forth below;

NOW, THEREFORE, to all whom it may concern, be it known that for good and valuable consideration, the receipt and sufficiency of which by the Assignor from the Assignee is hereby acknowledged, the Assignor has sold, assigned, set over, and transferred, and by these presents does sell, assign, set over and transfer unto the Assignee, its successors or assigns, the entire right, title and interest in and to the Intellectual Property including, but not limited to, the rights in and to all patents for all inventions and improvements disclosed in the Intellectual Property, including all reissues or extensions of such patents, and in and to any and all patents that have been granted in any foreign countries on the Intellectual Property, including an assignment of all rights under the provisions of international conventions (including without limitation the Paris Convention for the Protection of Industrial Property, the International Patent Cooperative Union, the European Patent Convention and the Common Market Convention), together with all claims for damages by reason of past, present or future infringement of said patents, with the right to sue for and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of their successors, assigns and legal representatives; and the Assignor does hereby authorize and request the responsible officials of each responsible patent office to issue or grant any and all patents upon the aforesaid Intellectual Property to the Assignee as the




assignee of the entire right, title and interest in and to the same, for the use of the Assignee, its successors, assigns and legal representatives;
