DEED OF ASSIGNMENT

THIS ASSIGNMENT is made the 5th day of August 2009.

BETWEEN

- (1) **OneWorld Enterprises Limited** 萬宇企業有限公司, a limited liability company incorporated under the laws of Hong Kong, having its registered office at Flat 1601, 16/F, Enterprise Square Two, 3 Sheung Yuet Road, Kowloon Bay, Kowloon, Hong Kong ("**Assignor**"); and
- (2) **OneWorld Solutions Limited** 鍵邦世界有限公司, a limited liability company incorporated under the laws of Hong Kong having its registered office situate at Rooms 308, Metro Centre, Phase 1, 32 Lam Hing Street, Kowloon Bay, Hong Kong ("**Assignee**").

WHEREAS:

- (A) The Assignor is the proprietor of the Intellectual Property Rights (as defined below).
- (B) The Assignor has agreed to assign to the Assignee all the Assignor's rights, titles, benefits and interests of, in and to the Intellectual Property Rights.

THIS ASSIGNMENT WITNESSES as follows:

1. DEFINITIONS

- 1.1 In this Assignment, the following expressions have the following meanings unless inconsistent with the context or otherwise specified:-

"Intellectual Property Rights" means trade names, brand names, patents, registered or applied for trade marks, registered designs, copyrights, design and copyright in all drawings, plans, specifications, computer software, domain names and internet keywords created by the Assignor and all know-how so created in any part of the world including but not limited to the intellectual property rights as listed in the Schedule.

"Hong Kong" means the Hong Kong Special Administrative Region of People's Republic of China.

2. ASSIGNMENT

- 2.1 In consideration of [REDACTED] paid by the Assignee to the Assignor (the receipt of which the Assignor hereby acknowledges), the Assignor, as the sole legal and beneficial owner of the Intellectual Property Rights, assigns to the Assignee all the property, right, title and interest throughout the world in and to:

- (i) the Intellectual Property Rights;

- (ii) the goodwill and reputation developed in relation to the business in the goods and/or services carried on by the Assignor arising from the use of the Intellectual Property Rights; and
 - (iii) the right to bring proceedings in respect of any infringement of any of the Intellectual Property Rights whether committed before or after the date of this Assignment including the right to claim damages and such other relief as may be available in respect thereof.
- 2.2 The Assignor acknowledges and confirms that all rights, titles, benefits and interests of, in and to the above in clause 2.1, as between the Assignor and the Assignee, be vested in the Assignee with effect from 10th August, 2009.

3. WARRANTIES

3.1 The Assignor hereby represents and warrants to the Assignee that:

- (i) it is the sole legal and beneficial owner of the Intellectual Property Rights;
- (ii) it has full power and authority to assign the Intellectual Property Rights to the Assignee in the manner set out in this Assignment and carry out the actions contemplated hereunder, and that the entry by its signatories hereto and performance under the terms of this Assignment will not infringe any rights of any third party or cause it to be in breach of any obligations to any third party;
- (iii) where any Intellectual Property Rights were created by an employee of the Assignor during such employee's employment with the Assignor, the Assignor warrants that any moral rights (whether conferred by the Copyright Ordinance, Cap 528 Laws of Hong Kong or otherwise) possessed now or at any time by any of such employees in respect of its copyright works have been irrevocably and unconditionally waived in favour of the Assignee, its successors and assigns;
- (iv) the execution and delivery of this Assignment will not violate any instrument to which the Assignor is a party or by which its assets are bound;
- (v) it shall indemnify the Assignee against all and any loss, awards, damages or costs (including without prejudice the legal costs of the Assignee on a solicitor and own client basis) sustained by the Assignee howsoever arising directly or indirectly as a result of any breach or non-performance by the Assignor of any of its warranties obligations or undertakings under this Deed; and
- (vi) at the request of the Assignee, the Assignor shall provide all reasonable assistance to enable the Assignee to resist any claim, action or proceedings brought against the Assignee as a consequence of the Assignor's breach of its warranties, obligations or undertakings under this Assignment.

4. WAIVER OF MORAL RIGHTS

- 4.1 The Assignor irrevocably and unconditionally waives in favour of the Assignee, its successors and assigns only, all and any moral rights (whether conferred by the Copyright Ordinance, Cap 528 Laws of Hong Kong or otherwise) which the Assignor may now or at any time possess in respect of its copyright works.

5. FURTHER ASSURANCE

- 5.1 The Assignor shall, at its own costs, promptly execute and do all such assurances, acts, deed and things as the Assignee may require to give full effect to this Assignment and to vest in the Assignee the full benefits of the Intellectual Property Rights.
- 5.2 The Assignor will at any time hereafter at the direction and expense of the Assignee take such actions and/or render all such assistance with any proceedings which may be brought by or against the Assignee in relation to the Intellectual Property Rights.

6. SUCCESSORS AND ASSIGNS

- 6.1 This Assignment shall be binding upon and enure to the benefit of the parties hereto and their respective successors and assigns.

7. GOVERNING LAW AND JURISDICTION

- 7.1 This Assignment shall in all respects be governed by and construed in accordance with the laws of the Hong Kong.
- 7.2 The parties hereto hereby irrevocably submit to the non-exclusive jurisdiction of the Hong Kong courts.

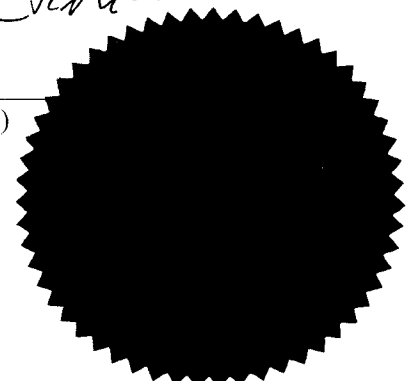

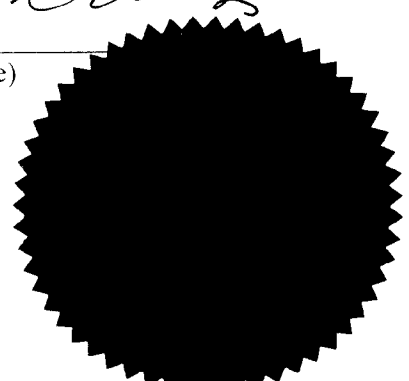
