**RELEASE OF SECURITY INTEREST IN PATENTS**

("Goldman") and Company and as modified by that certain Resignation and Appointment of Agent Under Patent Security Agreement, dated as of August 15, 2008, by and between Goldman and Wells and that certain Pledge Agreement dated as of June 11, 2010, by Company in favor of Wells (collectively, the "Patent Security Agreements")), including, without limitation, those patents, patent applications and patent licenses listed on Schedule I attached hereto and incorporated herein (collectively, the "Patents").

Wells consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may

reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Patents.
