CERTIFICATE OF AMENDMENT  
OF THE CERTIFICATE OF INCORPORATION  
OF

GTE SERVICE CORPORATION

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

1. The name of the corporation is GTE Service Corporation.
2. The certificate of incorporation of said corporation was filed by the Department of State on the 31<sup>st</sup> day of August, 1932, and under the original name of: Associated Telephone Utilities Company, Incorporated.
3. (a) The certificate of incorporation is amended to change the name of the corporation to Verizon Corporate Services Group.  
(b) To effect the foregoing, Article FIRST is amended to read in its entirety as follows:
