**TERMINATION AND RELEASE OF
SECURITY INTEREST IN PATENT RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENT RIGHTS** (this "Termination and Release"), dated as of October 1, 2010, is made by **WILMINGTON TRUST FSB**, a federal savings bank, located at 50 South Sixth Street, Suite 1290, Minneapolis, MN 55402 (the "Administrative Agent"), in favor of **VISTEON GLOBAL TECHNOLOGIES, INC.**, a Michigan corporation, located at 1 Village Center Drive, Van Buren Township, MI 48111 (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Grant of Security Interest in Patent Rights dated June 13, 2006 ("Patent Agreement"), Grantor granted to JPMorgan Chase Bank, N.A. ("Predecessor Agent"), for itself and for the ratable benefit of certain secured parties, a security interest in the Patent Collateral (as defined in the Assignment of Security Interest defined below), including those patents set forth on Schedule A attached hereto;

WHEREAS, pursuant to that certain Successor Agent Agreement and Amendment dated April 15, 2009 and that certain Assignment of Security Interest in Patents dated April 15, 2009 ("Assignment of Security Interest"), Predecessor Agent assigned all of its rights, powers, privileges and obligations under the Patent Agreement to the Administrative Agent;

WHEREAS, the Assignment of Interest was recorded in the Patent Division of the United States Patent and Trademark Office on April 24, 2009 at Reel 022584, Frame 0473 for the purpose of providing Patent Collateral as collateral security for the payment and performance of certain obligations of the Grantor to the Administrative Agent;

WHEREAS, Grantor has paid all of its outstanding obligations to the Administrative Agent; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges any and all security interest it has against the Patent Collateral without representation, warranty or recourse of any kind or nature.

The Administrative Agent shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments) reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Termination and Release.
