ASSIGNMENT OF PATENT RIGHTS

Whereas, Jasmin Cosic executed an Assignment of Patent dated April 9, 2007, assigning U.S. Patent No. 7113946 named "Universal Data Management Interface" to "Fabih," a company formed in the City of Woonsocket, Rhode Island with a mailing address of 41 Benefit Street, City of Pawtucket, Rhode Island (hereinafter "**Fabih**");

Whereas, Jasmin Cosic executed an Assignment of Patent dated April 9, 2007, assigning U.S. Patent No. 7117225 named "Universal Data Management Interface" to Fabih;

Whereas, Jasmin Cosic executed an Assignment of Patent Application dated June 7, 2007, assigning U.S. Patent Application No. 11/072845 named "Universal Data Management Interface" to Fabih;

Whereas, Jasmin Cosic executed an Assignment of Patent Application dated June 7, 2007, assigning U.S. Patent Application No. 11/072030 named "Universal Data Management Interface" to Fabih;

Whereas, each of such assignments was recorded in the United States Patent & Trademark Office in 2007 (together the "**Assignments**");

Whereas, "Fabih" is a d/b/a name of Fatima Cosic, an individual with an address of 45 Nye Street, Pawtucket, RI 02861 (hereinafter, "**Fatima Cosic**");

Whereas, Fabih Patent Nominee Trust, a nominee trust under the laws of the Commonwealth of Massachusetts, was created pursuant to a Declaration of Nominee Trust of Fabih Patent Nominee Trust dated as of December 31, 2007, and effective as of April 9, 2007 (such trust, the "**Fabih Nominee Trust**");

Whereas, Fatima Cosic, d/b/a Fabih, is the sole trustee of Fabih Nominee Trust;

Whereas, Jasmin Cosic is the sole beneficiary of the Fabih Nominee Trust holding 100% beneficial interest in the Fabih Nominee Trust;

Whereas, each of (1) Fabih, (2) Fatima Cosic, in her individual capacity, (3) Fatima Cosic d/b/a Fabih, and (4) the Fabih Nominee Trust, (together with Fabih, Fatima Cosic, and Fatima Cosic d/b/a Fabih, the "**Assignors**") wishes to sell, assign, transfer and convey back to Jasmin Cosic, in her individual capacity and not in her capacity as sole beneficiary of Fabih Nominee Trust, any and all of the rights, title and interest in the Patent Rights;

Now, therefore, each of the Assignors do hereby sells, assigns, transfers, and conveys unto Jasmin Cosic, residing at 912 York Avenue, Pawtucket, RI 02861, in her individual capacity and not in her capacity as a sole beneficiary of Fabih Nominee Trust (the "**Assignee**"), all right, title, and interest such Assignor has, whether severally or jointly with any other Assignor or the Assignee, that exist today and may exist in the future in and to any and all of the following (collectively, the "**Patent Rights**");

(a) the patent applications, patents, and the provisional patent application listed in the table below (the "**Patents**");

(d) all foreign patents, patent applications, and counterparts relating to any item in any of the foregoing categories (a) through (c), including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances;

(e) all items in any of the foregoing in categories (b) through (d), whether or not expressly listed as Patents below and whether or not claims in any of the foregoing have been rejected, withdrawn, cancelled, or the like;

(f) inventions, invention disclosures, and discoveries described in any of the Patents and/or any item in the foregoing categories (b) through (e) that (i) are included in any claim in the Patents and/or any item in the foregoing categories (b) through (e), (ii) are subject matter capable of being reduced to a patent claim in a reissue or reexamination proceedings brought on any of the Patents and/or any item in the foregoing categories (b) through (e), and/or (iii) could have been included as a claim in any of the Patents and/or any item in the foregoing categories (b) through (e);

(g) all rights to apply in any or all countries of the world for patents, certificates of invention, utility models, industrial design protections, design patent protections, or other governmental grants or issuances of any type related to any item in any of the foregoing categories (a) through (f), including, without limitation, under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperation Treaty, or any other convention, treaty, agreement, or understanding;

(h) all causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents and/or any item in any of the foregoing categories (b) through (g), including, without limitation, all causes of action and other enforcement rights for

- (1) damages,
- (2) injunctive relief, and
- (3) any other remedies of any kind

for past, current, and future infringement; and

(i) all rights to collect royalties and other payments under or on account of any of the Patents and/or any item in any of the foregoing categories (b) through (h).

Each of the Assignors represents, severally and jointly with other Assignors, warrants and covenants that:

(1) Such Assignor has the full power and authority, and has obtained all third party consents, approvals and/or other authorizations required to enter into this Assignment and to carry out her or its obligations hereunder, including the assignment of the Patent Rights to Assignee; and

(2) Prior to her or its execution of this document, such Assignor has not assigned or granted, and by this document confirm that she or it has not assigned or granted, any right, title, and interest to the Patent Rights. The Patent Rights are free and clear of all liens, claims, mortgages, security interests or other encumbrances, and restrictions. There are no actions, suits, investigations, claims or proceedings threatened, pending or in progress relating in any way to the Patent Rights. There are no existing contracts, agreements, options, commitments, proposals, bids, offers, or rights with, to, or in any person to acquire any of the Patent Rights.

Each of the Assignors hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or

issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.

Each of the Assignors will, at the reasonable request of Assignee and without demanding any further consideration therefore, do all things necessary, proper, or advisable, including without limitation, the execution, acknowledgment, and recordation of specific assignments, oaths, declarations, and other documents on a country-by-country basis, to assist Assignee in obtaining, perfecting, sustaining, and/or enforcing the Patent Rights.

The terms and conditions of this Assignment of Patent Rights will inure to the benefit of Assignee, her successors, assigns, and other legal representatives and will be binding upon Assignors, her successors, assigns, and other legal representatives.


