
WHEREAS, Assignee, is desirous of acquiring the entire right, title and interest in and to U.S. Patent No. 6,776,445;

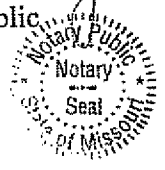
