ASSIGNMENT OF PATENT RIGHTS

WHEREAS, the undersigned (hereinafter referred to as "ASSIGNOR") has invented certain new and useful improvements for TWO-PART COSMETIC PRODUCT WITH SWELLING EFFECT TO BIOLOGICAL SURFACES, for which a U.S. non-provisional patent application was filed on August 10, 2010, as Application No. 12/866,971.

FURTHER, ASSIGNOR agrees that I will communicate to said ASSIGNEE, or its representatives, any facts known to me respecting said invention; testify in any legal proceedings; sign all lawful papers; execute all divisional, continuation, substitution, renewal, and reissue applications; execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE; make all rightful oaths; and generally do everything possible to aid the said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.

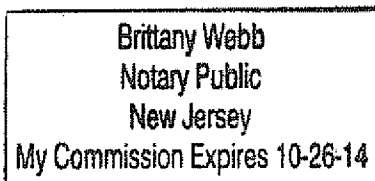

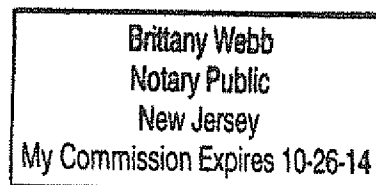
