
3. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters



the system, the system may be implemented in a computer system or a network of computer systems.

1. A method for providing a user with a graphical user interface for a system, the method comprising: receiving a request from a user to view a graphical user interface for a system; and displaying the graphical user interface for the system to the user.

2. The method of claim 1, wherein the graphical user interface for the system is displayed on a computer system, the computer system comprising a processor and a display device, the method further comprising: displaying the graphical user interface for the system on the display device of the computer system; and receiving a request from the user to view the graphical user interface for the system on the display device of the computer system.

3. A system for providing a user with a graphical user interface for a system, the system comprising:
