The Lender hereby terminates, releases and discharges its security interest in the Patent Collateral, together with all products and proceeds thereof, including without limitation, any claims by Assignor against third parties for past, present or future (a) infringement or dilution of any Patent, or (b) injury to the goodwill associated with any Patent, without representation, warranty or recourse of any kind or nature (together with the Patent Collateral, the "Patent Rights").
- 3. <u>Reassignment</u>. The Lender hereby reassigns, grants and conveys to Assignor, without any representation, recourse or undertaking by the Lender, all of the Lender's right, title and interest in and to the Patent Collateral and the Patent Rights.
