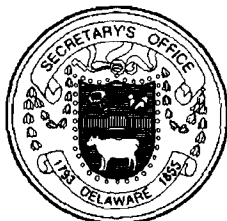

Zodiac Pool Systems, Inc., a Delaware corporation (the "Company"), hereby certifies pursuant to Title 8, Section 251(c) of the Delaware General Corporation Law (the "DGCL") as follows:

**FIRST:** The Company is a corporation organized and existing under the laws of the State of Delaware.

**SECOND:** Zodiac Pool Care, Inc. ("ZPC") is a corporation organized and existing under the laws of the State of Delaware.

**THIRD:** The Agreement and Plan of Merger dated September 23<sup>rd</sup>, 2010 between the Company and ZPC (the "Merger Agreement"), setting forth the terms and conditions of the merger of ZPC with and into the Company (the "Merger") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 251 of the DGCL.

**FOURTH:** The name of the Surviving Corporation shall be "Zodiac Pool Systems, Inc." (the "Surviving Corporation").

**FIFTH:** The Certificate of Incorporation of the Company as in effect immediately prior to the Merger shall be the Certificate of Incorporation of the Surviving Corporation.

**SIXTH:** An executed copy of the Merger Agreement is on file at the principal place of business of the Surviving Corporation at the following address: 6000 Condor Drive, Moorpark, CA 93021.


**SEVENTH:** A copy of the Merger Agreement will be furnished by the Surviving Corporation, upon request and without cost, to any stockholder of the constituent corporations.

**EIGHTH:** This Certificate of Merger, and the Merger provided for herein, shall become effective at 11:59 p.m. EST on September 23<sup>rd</sup>, 2010.
