ASSIGNMENT

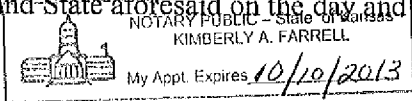

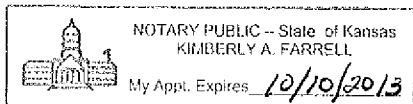
