Assignor hereby covenants with Assignee, its successors, assigns, and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the rights to the Invention herein conveyed has been made to other by the undersigned, and that the full right to convey as herein expressed is possessed by the undersigned.
