

**CERTIFICATE OF OWNERSHIP
MERGING
SIEMENS CORPORATE RESEARCH, INC.,

SIEMENS CORPORATION**

(Pursuant to Section 253 of the Delaware General Corporation Law)

Siemens Corporation (the "**Corporation**"), a corporation incorporated on June 8, 1989, pursuant to the provisions of the Delaware General Corporation Law (the "**DGCL**");

DOES HEREBY CERTIFY that the Corporation owns 100% of the capital stock of **Siemens Corporate Research, Inc.**, a corporation incorporated on the 25th day of August, 1988 pursuant to the provisions of the DGCL; and that the Corporation, by a resolution of its Board of Directors duly adopted by unanimous written consent as of the 9th day of March, 2009, determined to merge into itself the said Siemens Corporate Research, Inc., **effective as of 12:01am, Eastern Standard Time, on October 1, 2009**, which resolution is in the following words to wit:

WHEREAS, the Corporation lawfully owns 100% of the outstanding stock of Siemens Corporate Research, Inc. a corporation organized and existing under the laws of the State of Delaware, and


WHEREAS, the Corporation desires to merge into itself the said Siemens Corporate Research, Inc. and to be possessed of all the estate, property, rights, privileges and franchises of said corporation,

NOW, THEREFORE, BE IT RESOLVED, that effective as of 12:01am, Eastern Standard Time, on October 1, 2009, the Corporation merge into itself the said Siemens Corporate Research, Inc., and assume all of its liabilities and obligations, and

FURTHER RESOLVED, that the officers of the Corporation be, and they hereby are directed to make and execute a certificate of ownership setting forth a copy of the resolutions to merge the said Siemens Corporate Research, Inc. and assume its liabilities and obligations, and the date of adoption and effectiveness thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

FURTHER RESOLVED, that the officers of the Corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in any way necessary or proper to effect said merger and, in advance of such merger, do all such acts and things whatsoever, which may be in any way necessary, desirable or appropriate to effect an orderly transition of said Siemens Corporate Research, Inc. from being a stand-alone entity to being integrated into the Corporation (as of the effective time) as a division of the Corporation or as may otherwise be determined by the executive management of the Corporation from time to time.
