PATENT ASSIGNMENT

THIS ASSIGNMENT, made and effective the 9th day of September 2010, by and between **Delphi Technologies, Inc.**, a Delaware Corporation, located at 5725 Delphi Drive, Troy, Michigan 48098, (hereinafter ASSIGNOR), and **BWI Company Limited S.A.**, a company existing under the laws of Luxembourg, located at 1, rue des Glacis L-1628, Luxembourg, (hereinafter ASSIGNEE).

WITNESSETH

WHEREAS, ASSIGNOR is desirous of assigning its interest in the issued patents, pending patent applications, and registrations as set forth in **Exhibit A**, identified by the United States Patent Office or foreign Patent Office Serial Number or Patent Number and other information (hereinafter the PATENTS AND PATENT APPLICATIONS);

WHEREAS, ASSIGNEE is desirous of owning the entire right, title and interest in and to said PATENTS AND PATENT APPLICATIONS, including the right to sue for past damages.

For good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound thereby, the parties hereby agree as follows:

NOW THEREFORE

1. ASSIGNOR does hereby assign, convey, transfer, and set over to ASSIGNEE, its successors, assigns or other legal representatives, the entire right, title and interest, domestic and foreign, throughout the world, in and to said PATENTS AND PATENT APPLICATIONS, to have and to hold the interests herein assigned to the full ends of the terms of the PATENT AND PATENT APPLICATIONS and any and all divisions, reexaminations, substitutions, reissues, continuations, continuations-in-part, renewals, and/or extensions thereof respectively, including the right of ASSIGNEE, its successors, assigns or other legal representatives to make applications and to receive PATENTS AND PATENT APPLICATIONS for inventions and discoveries therein in any and all foreign countries/regions in its name, at its election as well as the right to sue for past infringement and recover any damages for same, and ASSIGNOR hereby assigns, convey, transfer and sets over to ASSIGNEE, its successors, assigns, or other legal representatives, all rights of priority in and to the PATENTS AND PATENT APPLICATIONS and inventions and discoveries therein in all countries/regions to be held and enjoyed by the ASSIGNEE for its own use and benefit, and for the benefit of its legal representatives, successors and assigns to the full end of the terms of all of the PATENTS AND PATENT APPLICATIONS which may be granted on the inventions as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this assignment not be made.

2. The ASSIGNOR represents and warrants that ASSIGNOR is the sole and exclusive lawful owner of all rights, title, and interest in and to the PATENTS AND PATENT APPLICATIONS; that the PATENTS AND PATENT APPLICATIONS have not been assigned or otherwise transferred, encumbered or affected by ASSIGNOR; and that the ASSIGNOR has the authority and full right to make this ASSIGNMENT.

3. The ASSIGNOR further covenants and agrees that the ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to the PATENTS AND PATENT APPLICATIONS as may be known and accessible to ASSIGNOR and will testify as to the same in an interference or litigation related thereto and will promptly execute and deliver to the ASSIGNEE or its legal representative any and all papers, instruments or affidavits that may be necessary or desirable to apply for, obtain, maintain, issue and enforce and to perfect the title to any of the PATENTS AND PATENT APPLICATIONS, divisions, reexaminations, substitutions, reissues, continuations, continuations-in-part, renewals, and/or extensions thereof in the United States or any foreign countries that may be necessary or desirable to carry out the purposes thereof.

IN WITNESS WHEREOF, the ASSIGNOR and ASSIGNEE hereto have executed this ASSIGNMENT as of the day and year above written.




