3. The Assignors agree to perform all affirmative acts which may be necessary to obtain a grant of a valid United States patent to the Assignee.
4. The Assignors hereby authorize and request the Commissioner of Patents to issue any and all Letters Patent of the United States resulting from the Application or any division or divisions or continuing applications thereof to the Assignee, as Assignee of the entire interest, and each hereby covenants that he has full right to convey the entire interest herein assigned and that he has not executed and will not execute any agreement in conflict herewith.
5. The Assignors hereby grant the firm of McANDREWS, HELD & MALLOY, LTD. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent Office for recordation of this document.
