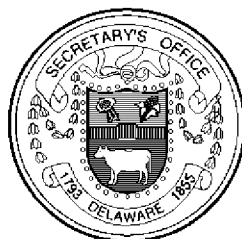

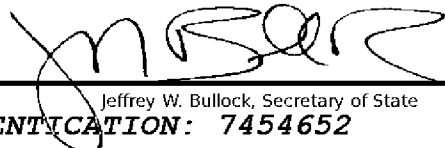

Cardinal Health 207, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*Corporation*"), does hereby certify:

ONE: That on July 29, 2009 resolutions were duly adopted by the Corporation's Board of Directors setting forth, approving and adopting a proposed amendment to the Corporation's Certificate of Incorporation (the "*Certificate*"), and declaring such amendment to be advisable and recommended for approval by the Corporation's stockholders, and that such resolutions provide that:

Article First of the Certificate shall be amended and restated to read in its entirety as follows:

"FIRST: The name of the Corporation is CareFusion 207, Inc."

TWO: That on July 29, 2009 the Corporation's stockholders approved such amendment by vote of the outstanding shares in accordance with Section 228 of the General Corporation Law of the State of Delaware.
