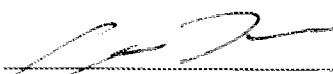

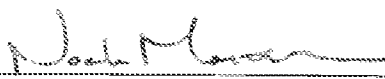
We hereby agree, without further consideration and without expense to us, to execute all papers necessary in connection with the United States and foreign applications when called upon to do so by PPC.
