INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "**Agreement**") is entered into as of September 30, 2010 by and between **SPRING CAPITAL PARTNERS II, L.P.** ("**Lender**") and **BODYMEDIA, INC.**, a Delaware corporation ("**Grantor**").

RECITALS

A. Lender has agreed to make certain advances of money and to extend certain financial accommodations to Grantor (the "**Loans**") in the amounts and manner set forth in that certain Loan and Security Agreement by and between Lender and Grantor, dated as of the date hereof (as the same may be further amended, modified or supplemented from time to time, the "**Loan and Security Agreement**"; capitalized terms used herein are used as defined in the Loan and Security Agreement).

B. Lender is willing to extend financial accommodations to Grantor, but only upon the condition, among others, that Grantor shall grant to Lender a security interest in certain trademarks, patents and copyrights to secure the obligations of Grantor under the Loan and Security Agreement.

C. Pursuant to the terms of the Loan and Security Agreement, Grantor has granted to Lender a security interest in all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of the Liabilities, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure its obligations in connection with the Liabilities, Grantor grants and pledges to Lender a security interest in all of Grantor's right, title and interest in, to and under its Intellectual Property (including without limitation those patents, trademarks, service marks and copyrights listed on Exhibits A, B and C, respectively), and including without limitation all registrations or pending applications therefor, the goodwill of the business associated therewith, all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof (collectively, "**Intellectual Property Collateral**").

This security interest is granted in conjunction with the security interest granted to Lender under the Loan and Security Agreement. The rights and remedies of Lender with respect to the security interest granted hereby are in addition to those set forth in the Loan and Security Agreement and the other Loan Documents, and those which are

now or hereafter available to Lender as a matter of law or equity. Each right, power and remedy of Lender provided for herein or in the Loan and Security Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Lender of any one or more of the rights, powers or remedies provided for in this Agreement, the Loan and Security Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Lender, of any or all other rights, powers or remedies. In the event of any irreconcilable conflict between the terms of this Agreement and the Loan and Security Agreement, the terms of the Loan and Security Agreement shall control.

Grantor represents and warrants that Exhibits A, B and C attached hereto set forth any and all intellectual property rights in connection with which Grantor has registered or filed an application with the United States Patent and Trademark Office, the United States Copyright Office, or foreign patent offices, as applicable.

This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania, without regard to principles of conflicts of law.
