#### RELEASE OF PATENT SECURITY AGREEMENT

WHEREAS, pursuant to that certain Patent Security Agreement, dated as of July 17, 2007 (the "Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 19597, Frame 108 on July 24, 2007, ARLON, INC. and SOUTHERN SAW ACQUISITION CORPORATION, both Delaware corporations (collectively, jointly and severally, "Releasees" and each individually "Releasee"), granted to ABLECO FINANCE LLC ("Releasor"), as administrative agent for certain lenders, a continuing first priority security interest (subject only to Permitted Priority Liens (as defined in the Credit Agreement, dated as of July 17, 2007, as amended, restated, supplemented or otherwise modified from time to time, among Bairnco Corporation, certain of its subsidiaries, certain lenders and Releasor (the "Credit Agreement") or the Security Agreement, dated as of July 17, 2007, as from time to time amended restated, supplemented or otherwise modified, among Releasees and Releasor (the "Security Agreement")) in all right, title and interest of Releasees in, to and under the following, whether then-existing or thereafter created or acquired (collectively, the "Patent Collateral"): (i) all of the Patents (as defined in the Credit Agreement or the Security Agreement) and Patent Intellectual Property Licenses (as defined in the Credit Agreement or the Security Agreement) to which a Releasee is a party, including those referred to on Schedule I attached hereto; (ii) all reissues, continuations or extensions of the foregoing; and (iii) all products and proceeds of the foregoing, including any claim by such Releasee against third parties for past, present or future infringement or dilution of any Patent or any Patent licensed under any Intellectual Property License (as defined in the Credit Agreement or the Security Agreement); and

WHEREAS, Releasees have requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its continuing first priority security interest in the Patent Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby releases, relinquishes and discharges its first priority continuing security interest in the Patent Collateral.
