ASSIGNMENT

WHEREAS, we, GEOFFREY B. RHOADS, of West Linn, State of Oregon, and AMMON E. GUSTAFSON, of Beaverton, State of Oregon, have invented a certain invention, entitled INFERRING OBJECT STATUS BASED ON DETECTED WATERMARK DATA, for which we have made application for Letters Patent of the United States, said application having been filed by us on March 28, 2002, and assigned application no. 10/112,647; and
