ORION does hereby sell, assign, and transfer, and hereby set over unto INNOVATECH, its successors, assigns and legal representatives, the full and exclusive right, title and interest to said inventions in the United States of America and all foreign countries, including, without limitation, said inventions as described in said patent applications and patents, to be held and enjoyed by INNOVATECH, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by ORION had this assignment and sale not been made, including, without limitation, (i) all rights to the aforesaid patent applications and to any United States Letters Patent therefor, when issued together with all improvements thereon and betterments thereof, (ii) all related patent applications including, but not limited to, divisions, continuations, continuations-in-part, reissues and reexaminations thereof and substitutions of or for said patent applications, (iii) all foreign rights including the right to make application for Letters Patent for said inventions in any and all foreign countries and the right to claim priority as to the filing date under the International Convention on the basis for said patent applications for United States Letters Patent, and (iv) all income, royalties, damages and payments due or payable to ORION as of the execution of this Assignment or thereafter, including, but not limited to, all claims for damages by reason of past, present or future infringement or other unauthorized use of the patent applications and inventions assigned hereunder, together with the right to sue for, and collect the same.

ORION hereby authorizes and requests the Commissioner of Patents to issue all Letters Patent issuing therefrom to INNOVATECH, for its successors, assigns and legal representatives.

ORION hereby agrees to execute any papers, provide any information, and have its employees testify in any interference or litigation at the request of INNOVATECH, its successors, assigns and legal representatives, when deemed essential to INNOVATECH's, its successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such patents, patent applications and inventions and rights hereby transferred.

ORION furthermore agrees upon request of INNOVATECH, its successors, assigns and legal representatives, and without further remuneration, to execute any and all papers desired by INNOVATECH, its successors, assigns and legal representatives, for the filing and granting of foreign applications and the perfecting of title thereto in INNOVATECH, its successors, assigns and legal representatives.

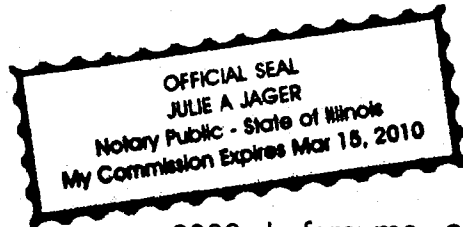
